**FINAL DISPOSITION:** Governor signed into law on 4/27/17

**SB1082:** motorcycle safety fund  
**WHAT IT DOES:**  
 Reinstates the collection of \$1 per motorcycle registration to be used for the Motorcycle Safety Fund  
**OUR POSITION:** SUPPORT  
**FINAL DISPOSITION:** Governor signed into law on 3/14/2017

**WHAT IT DOES:** Requires that operators and passengers of motorcycles, ATVs, and motor driven cycles wear a protective helmet at all times.  
**OUR POSITION:** OPPOSE  
**FINAL DISPOSITION:** defeated in committee 8-0

**HB2477:** civil forfeiture; report information; remedies  
**WHAT IT DOES:** Increases the standard of proof for the state in forfeiture actions  
**OUR POSITION:** SUPPORT  
**FINAL DISPOSITION:** Governor signed into law on 4/12/2017
